





At the end of the vintage date, the fund is expected to be liquidated with net proceeds returned to investors. The strategy's investment objective is to generate a superior risk-adjusted rate of return above what can be earned with an investment grade bond portfolio held to maturity through the vintage date. The goal is to provide enhanced income (or to reinvest for total return) over the vintage date time horizon while managing the underlying risk to the principal. The strategy is benchmarked against the Bloomberg Barclays US Intermediate Credit Index.


